

### A LETTER FROM YOUR SUPERINTENDENT AND BOARD PRESIDENT

Dear Community Members,

We are excited to share with you that all residents in the Dryden Central School District will have the opportunity to vote on the proposed budget for the 2022-2023 school year **in person** on Tuesday, May 17, 2022. Residents can vote from 7:00 AM to 9:00 PM in the MS/HS Auditorium located at 118 Freeville Road Dryden, NY 13053. Voters should look for signage directing them to the auditorium.

### We believe that a safe, joyful and nurturing environment promotes learning and growth.

If residents are experiencing COVID-19 symptoms, they should not come to campus to vote. We need everyone to do their part to ensure infection rates in our schools, community, and county continue to remain low.

#### We cultivate resilience and build strength of character.

This past school year has been one filled with joy and challenges as we work to return to in person instruction five days a week while moving through the many complex issues related to the pandemic. We were proud to be able to **safely** develop a plan to return to in person instruction and fulfill our mission to educate and empower each learner to achieve excellence and build a better world. Costs related to filtration, personal protective equipment, additional sanitization supplies, thermometers, temperature scanners, and additional professional development are just a few examples of unfunded expenses at the intersection of public education and the pandemic.

#### We believe that positive partnerships and relationships are essential.

As you may recall, two years ago at the onset of the pandemic, the District did not raise the tax levy as we know that many families and businesses were hit hard in the early days of the pandemic. While our state aid has increased slightly, the increase does not match the inflation that we are all experiencing. The District is working hard to balance its needs so that we are able to continue to offer our students a robust program to prepare them for life post-Covid.

#### We act with integrity and accountability.

As you will see the proposed budget is largely a roll over budget. This year the Board of Education has adopted a \$45,311,906 budget. This represents a 4.07% increase over the

21-22 budget. The 4.07% increase is related to contractual and salary increases as well as legally obligated contributions to the NYS Teacher Retirement System and the NYS Employee Retirement System. Inflation related to commodities such as fuel is contributing to the increase in the budget as well. So, despite exercising fiscal responsibility, there is a gap between revenues and expenses.

The District will be closing that gap using unassigned fund balance and reserve money. The District will be using the Federal funds to cover some costs related to the pandemic and develop programming to support our students PK-12 with social, emotional and academic needs as a result of the pandemic.

For all of these reasons, the District has calculated a 2.69% tax levy increase for the 22-23 Budget. The tax levy was calculated in alignment with all laws and regulations. This does not mean a business' or household's school taxes will be going up 2.69%. This is the percentage increase that the District can place on the revenues that the District currently collects through taxes. This tax levy increase is in line with the rest of the school districts in Tompkins County. Again, two years ago the District put forth a budget for community approval with a 0% tax levy increase.

We have always been grateful for the support that we have received from our community. This budget has been developed in good faith. The District has tried to weigh the perspectives of the taxpayer, the staff, and our students. This budget does not eliminate critical programming the District needs to fulfill our mission and our obligations to our students and staff while "tightening our belts".

We are proud of our community, our District and our #LionPride. We have overcome many obstacles and challenges this school year. There will be a public budget hearing on Monday, May 9, 2022 at 7:00 PM. The hearing will be recorded and posted to the District's website. # PROPOSITIONS AS THEY APPEAR ON THE BALLOT

#### **PROPOSITION 1:**

#### 2022-2023 SPENDING PLAN

Shall the following resolution be adopted, to wit:

RESOLVED: That the Dryden Central School District, as recommended by the Board of Education, adopt a spending plan for the 2022-2023 school year in the amount of \$45,311,906 and to levy the necessary tax therefor?

#### **PROPOSITION 2:**

#### **SCHOOL BUS BOND PROPOSITION**

Shall the Bus Bond Proposition set forth in the legal notice of this meeting authorizing the purchase of school buses and other transportation vehicles at a maximum cost of \$465,000 and providing that such sum shall be raised by a tax collectable in annual installments with District obligations to be issued in anticipation thereof, be approved?

#### **PROPOSITION 3:**

### UPGRADES TO CORRIDOR DOORS, WIRE GLASS AND THE KITCHEN AT FREEVILLE ELEMENTARY SCHOOL CAPITAL PROJECT PROPOSITION

Shall the proposition set forth in the legal notice of this meeting authorizing expending up to \$100,000 for the replacement of the corridor doors and wire glass; replacement of kitchen flooring, wall finish, ceiling and lights; replacement of the exterior Bilco Door, Gas House Structure and roof, and improvements to the well head structure at the Freeville Elementary School, with up to \$20,000 of such cost to be expended from the existing building capital reserve fund and the balance of such cost, or so much thereof as may be necessary, to be funded by state aid available, all as more fully described in said notice, be approved?

#### **PROPOSITION 4:**

#### SOUTHWORTH LIBRARY ASSOCIATION FUNDING PROPOSITION

Shall the proposition set forth in the legal notice of this meeting authorizing the Board of Education of the Dryden Central School District to levy taxes annually in the amount of \$50,000 and to pay over such monies to the Southworth Library Association, be approved?

The Southworth Library funding proposition is for an annual funding of \$50,000 and will help cover increased costs for staffing, materials and operations, needed for increased library usage and budget shortfalls. This does not impact the school budget in any way and it is the first time we have been on the school ballot. Local impact averages under \$15 per household."



### **ABSENTEE BALLOTS WILL BE AVAILABLE**

If you are eligible to use an Absentee Ballot because of physical disability, or legitimate absence from the District (business purposes, vacation, or studies) and are a qualified voter of the District, you may obtain an absentee ballot application by contacting Carrie Merriman, District Clerk, Dryden Central School, P.O. Box 88, Dryden, NY 13053, phone number 844-5361, ext. 1. Applications will be available between the hours of 9:00 a.m. and 4:00 p.m., Monday through Friday.

Any such application must be received by the District Clerk at least seven days before the date of the aforesaid annual district meeting (May 10, 2022) if the ballot is to be mailed to the voter, or the day before such annual district meeting (May 16, 2022) if the ballot is to be delivered personally to the voter. A list of all persons to whom absentee ballots shall have been issued shall be available for public inspection in the office of the District Clerk during regular office hours on each of the five days prior to the day of the vote (excluding Saturday and Sunday). Absentee ballots must be received in the office of the District Clerk not later than 5:00 p.m. prevailing time, on Tuesday, May 17, 2022.
